Dear Lord, for Him who came from Thee, To bear the sins of humanity, That we through Him might saved be, And share with Thee eternity, We thank Thee.



## Are Sabbath-Keepers Legalists?

"But we know that the law is good, if a man use it lawfully" (1 Timothy 1:8) Legalism...

It's a word we hear a lot about in religious circles, expecially we Sabbathkeepers. Those of us who observe each seventh day of the week as the day of rest and Christian worship are often faced with the implication, if not accusation, that we are legalists.

That charge is a serious one, and it deserves quiet consideration not quick dismissal. Legalists do not wear white hats—nor white robes. If Sabbatarianism can be equated with legalism, we had better abandon it.

But let's see: just what is "legalism"? The word itself is a combination of the root "legal" and the suffix "ism." "Legal" merely means "pertaining to the law," or "based on law." "Ism" suggests a system of belief or doctrine. "Legalism," then, would be defined as adherence to a system of belief based on law. A legalist would be one who takes his stand on the law.

That doesn't sound so bad at first hearing. All Christians are willing to admit the validity of certain laws for operation in the society, as well as in Christianity. No one who thinks logically will recommend that every existing rule be abrogated.

But legalism, as it is commonly discussed, describes more than an allegiance to certain laws. It involves a misuse of law; it is an overemphasis on law; it is an 'effort to make law perform above its capability; it is an unlawful use of the law. It is in this *abuse* of law that the error of legalism lies. The Bible insists that the law itself *must be*  used legally (1 Timothy 1:8)! DEFINITION: Legalism is an unlawful use of the law.

Where does the Bible mention any illegal uses of the law? Several places. Although the term 'legalism' does not occur in Scripture, the concept is probably best defined in the book of Galatians. Notice:

Knowing that a man is not justified by the works of the law, but by the faith of Christ Jesus, even we have believed in Jesus Christ, that we might be justified by the faith in Christ, and not by the works of the law: for by the works of the law shall no flesh be justified (Galatians 2:16).

Again:

I do not frustrate the grace of God; for if righteousness comes by the law, then Christ is dead in vain (Galatians 2:21).

And again:

Christ is become of no effect unto you, whosoever of you are justified by the law; ye are fallen from grace (Galatians 5:4).

Similar passages are found in Romans 3:20, 28; Acts 13:39; and elsewhere.

If one summarizes and correlates these texts, he must conclude that neither justification (forgiveness) nor righteousness come by keeping law; and, further, that whoever attempts to gain these blessings by law has thereby separated himself from Christ and from God's grace!

There we have in It is illegal to employ the law as a means of obtaining favor (justification or righteousness) with God. And it is also impossible! To think that lawkeeping is sufficient merit for salvation is tantamount to rejecting Christ as Savior. Paul never allows that anyone can merely "take his stand on the law" at the day of judgment, and receive an acquittal from God. To try is to use the law unlawfully—and that is the thrust of legalism!

DEFINITION: Legalism is the impossible attempt to use law-keeping as a means of gaining or keeping a right standing with God.

Such a favorable standing, according to the Word, comes only through a faith relationship with Jesus the Savior. Salvation, we must insist with Paul, is only by grace through faith in the only Perfect One. From beginning to end, salvation is in Christ—and in Him alone. He is Savior when we first believe, and He must remain Savior through the day of judgment. We can never save ourselves!

But the question remains, "Are Sabbatarian Christians legalists?"

A Sabbath-keeper is one who obeys literally the terms of the Fourth Commandment: "Remember the Sabbath day to keep it holy... The seventh day is the Sabbath of the Lord thy God" (Exodus 20:8,10). The Sabbatarian is convinced that God intended a specific 24-hour period of the weekly cycle to be His Sabbathnot just any day out of seven. Further, the Sabbath-keeper finds no Biblical evidence that God ever repealed or amended that command in favor of another plan. In God's economy of ruling His creation and men it it, the seventh-day Sabbath

stands. With these convictions, the Sabbatarian worships and rests each Sabbath day according to the commandment. Is that legalism?

It is important here that we focus on the Scriptural concept of legalism as a misuse of the law in an effort to merit God's salvation. The crucial issue, then, is in the *purpose* of the Sabbath-keeper instead of his *practice*. On the one hand, if he keeps Sabbath, thinking that he is thereby making himself right with God, YES— he has a legalistic approach. If, on the other hand, his Sabbath observance springs from valid motives, and all the while he remembers that His salvation is in Christ alone, NO—that man is no legalist!

Sabbatarian Christians, more than others, ought to understand clearly that their salvation is "not of works." The Sabbath itself is a perpetual

symbol and a weekly reminder that we are called to cease from our labors (to earn salvation) and enter by faith into God's rest. (See Hebrews 4:1-11.) On this divinely-appointed day, we not only terminate our week's work, but we also rest assured that all the work for our eternal welfare has been completed in the doing and dying of Jesus Christ.

The genuine Sabbath-keeping believer knows that he is neither earning nor improving his acceptance with God by his obedience, yet he persists in diligent obedience. Why? If our best law-keeping doesn't obtain salvation, then why should Sabbatarians jealously insist on continued regard for "remembering the Sabbath day," as well as all the other words that proceed from God's mouth?

#### It is the wrong spirit and motive of an act that makes it legalistic.

Informed Sabbath-keepers use many texts and expressions to answer this question. Each of them demonstrates that the law can be used lawfully, and that it is good to do so. Here are a few valid motives for obeying God's laws, with supporting texts:

- 1) Because we love God and are grateful for His salvation, we obey god and keep His Sabbath (1 John 5:3).
- 2) We obey God's Ten Commandments because they are taught in the New Testament as well as the Old (Matthew 19:16-19; James 2:10-12).
- 3) We obey God and keep His Sabbath because of Jesus' example (Luke 4:16; John 15:10).
- 4) Because faith is dead without works, we obey God's laws (James 2:17-26).
- 5) We obey God's commandments because (or as evidence that) we have been saved by grace not, in order to be saved (Ephesians 2:8-10).
- 6) Entrance into God's eternal kingdom is promised to the obedient—never the disobedient (Matthew 7:21-23; Revelation 22:14,15).
- 7) We practice obedience to God's laws because the Scriptures do not permit one who has been saved by grace to continue sinning—which is breaking God's laws (Romans 6:1,2; 1 John 3:4).

There should be no doubt that even the New Scriptures insist that genuine believers in God must render devoted obedience to His will and Word. To do so is *not* legalism. The abuse which some have made of the law (legalism) does not take away the Biblical use of it. As a definition of sin, as a restraint for the ungodly, and as a guide for the believer—the law has great and enduring value. When a divine appointment has been abused, do not cancel the appointment, but call it back to its lawful use. Legalism only occurs when one asserts his own obedience as grounds for his salvation.

No, obedience to God's laws is not legalism; but obedience with self-righteousness is! Obeying the Ten Commandments is not legalism, but obeying them with the thought of meriting salvation is! Observing the seventh-day Sabbath is not legalism; observing it with the motive of becoming righteous before God is!

Thus, legalism is not so much what one does, as it is why he does it. It is the wrong spirit and motive of an act that makes it legalistic, and not the act itself.

If I live in the presumption that my right actions are the basis of my acceptance with God, then *all* the good that I do is legalistic and of no avail with regard to my salvation. My service to the church is legalism; my honor to mother and dad is legalism; my refusal to kill my neighbor is legalism.

But if I live in the confidence that my acceptance with God is full and final only through the doing and dying of Jesus Christ, then I am free to do all the good works that I can, and to be as obedient to God's laws as possible—and no one can rightly hang the "legalist" tag on me.

Is Sabbath-keeping legalism? No more than honoring your parents, respecting your neighbor's property, or telling the truth.

It all depends on a man's faith. One whose saving faith is firmly anchored in Jesus Christ instead of his own imperfect performance has both the responsibility and the privilege of being obedient to every command that proceedeth out of the mouth of God!

One of those commands is "Remember the Sabbath day to keep it holy." Remembering it rightly is love not legalism!

A devastating famine is threatening the lives of many people in Cambodia, and there is something you can do to help. Our Lord Jesus starves whenever any of His brothers are hungry and thirsty (Matthew 25:35-40), and surely He is starving in Cambodia today.

A recent disaster bulletin from Church World Service calls for "an all-out effort of assistance to meet the desperate needs of the Cambodian people. If response is not made immediately, hundreds of thousands will die of starvation by Christmas." Church World Service is in a position to serve in ways that our Seventh , Day Baptist denomination cannot, but we can become a part of their ministry. They are appealing for money, and that is where you can help.

Let me suggest that you make out a check to our "SDB United Relief Fund," and on the memo line write: "Church World Service—Cambodia." This way you can give to Our World Mission and also participate in a larger ministry at the same time.

(If Church World Service is not your cup of tea, write "UNICEF or "International Red Cross" on your check; each is also helping out in Cambodia.)

Where can we find sources of money for our brothers and sisters, members of the human family, in their time of desperation? For one thing, money is freed for charitable giving when we eat only the amount of food we need in order to live and serve the Lord. Anything beyond that is self-indulgence, in disobedience to the One who said: "If anyone wishes to follow me, he must deny himself" (Luke 9:23). Money not spent on unnecessary groceries is money available for charitable giving.

I was shown another source of money for donation this summer, when a letter came to inform me that my subscription to Sports Illustrated magazine was about to run out. The \$30 it would have cost me to renew it went instead to India (through the United Relief Fund), where our fellow SDB's lost so much in a hurricane last spring. (Incidentally, your response to our appeal for this cause has been gratifying, and the people in India have expressed thanks to you through their executive secretary, B. John V. Rao.) By giving up things that we enjoy, we free money for the doing of God's pleasure.

Paul echoes Jesus' call for selfdenial when he writes: "Cease to live for yourself" (2 Corinthians 5:15). Thomas Merton adds this: "It is not only the evil in us that must be given up. We are even asked to give up many good things; but only in order

to get something better." As Jesus said: "Every branch that bears fruit, my Father will cut back—in order that it may produce more fruit" (John 15:2). It becomes a joy to do without good things once thought of as indispensable, to feel ourselves being cut back by the Gardener, in order that we might be more fruitful still.

Through Christian self-denial, money becomes available for serving the Lord. Through donations to the SDB United Relief Fund—designated for ministries such as that of Church World Service in Cambodia—we can take part in our Lord's work on a broader scale without going outside of Our World Mission.  $\Box$


#### PRESIDENT EXPRESSES APPRECIATION

#### **SAJO CAMP 1979** HOLLAND





## **NEW AUBURN CELEBRATES CENTENNIAL**

t was on June 9, 1879, that the Seventh Day Baptist Church of Auburn at Cartwright Mills, Chippewa Lounty, Wisconsin, was founded. The charter members were Mr. and Mrs. D.J. Cartwright, Mr. and Mrs. P.C. Stapleton, Mr. and Mrs. C.H. West, Mr. and Mrs. Perry Sweet, Mr. O.B. Hoard and Mrs. Merinda Hull.

That evening, the members met to consider the feasibility of building a house of worship. They voted to erect a building 20 ft. by 30 ft. The land was donated by Mr. and Mrs. Perry Sweet. Special music was provided by Mrs. Frances Clarke and Mrs. Janette Rogers, and Rev. Ed Sutton gave the children's message. Rev. S. Kenneth Davis of Battle Creek, using Philippians-3:12-14, spoke on "Pressing Toward the Goal," which was the theme for the week's activities. Communion was also administered with Rev. Earl Cruzan of Milton leading and the former pastors serving. Rev. Leroy Bass dismissed the meeting with the benediction.

### **BIBLE SABBATH ASSOCIATION ELECTS NEW OFFICERS FOR 1980**

In 1943 George A. Main, a Seventh Day Baptist layman and member of the Daytona Beach, Florida, church, began extensive correspondence with Sabbathkeepers around the country for the purpose of bringing them together in an organization that would foster unity and Sabbath outreach. In 1945 the Bible Sabbath Association was officially organized and today has a worldwide Sabbatarian outreach.

The object of the nonsectarian, nondenominational association is to bring together into one strong organization all believers in the Biblical seventh-day Sabbath (Saturday) regardless of sect, creed or denomination, for the sole purpose of spreading knowledge of, belief in, and observance of the Creator's Holy Day. The only qualification for membership is belief in the seventhday Sabbath.

The Association publishes a monthly magazine, The Sabbath Sentinel. Eugene Lincoln, a Seventh-day Adventist serves as Editor. The offices of the organization are located in Fairview, OK, where Mr. and Mrs.

It is imperative that we move forward together and cooperate with each other, actually complementing each other...Ecumenism is just now coming of age among Sabbatarians.'

President-elect Bevis states that he hopes to build on the good foundation. established in recent years in this new spirit of cooperation and love among all who are faithful to God's Holy Day. He expressed the desire that more Seventh Day Baptists take an active interest in the work of the Bible Sabbath Association and seek in other ways to work together with other Sabbatarians on a local as well as national level.

Once the riverboats came bringing cotton and merchandise to this city on the bluff. Today the riverboats are gone and "cotton row" on Front Street is comprised of fashionable shops and fine restaurants. The Cotton Exchange is still here and each year the city pays tribute to "King Cotton" with the cotton carnival.


Not far from Front Street and the riverfront one comes across Beal Street where the "Blues" were written by W.C. Handy, and to the edge of the sprawling metropolis is "Graceland" where today thousands are making the pilgrimage to the home of Elvis Presley/Memphis is truly a beautiful city noted for its fine homes, schools and churches. Everywhere there are parks with lovely flowers and shrubs revealing the great interest in beauty and nature of the people.

We came again to Memphis on a beautiful Sabbath Day, made even more beautiful by the event we were to witness, the organization of a new Seventh Day Baptist church. On this day, November 17, 1979, some fifty members and friends had gathered at the Frayser Church of the Nazarene to witness and give blessing to this newest part of the family of God.

It was barely eighteen months ago that William (Bill) Shoffner had written to the Tract Society in Plainfield requesting information about the beliefs of Seventh Day Baptists. Much has happened in those months; God has been at work.

Seventh Day Baptist Christians are alive in Memphis and actively sharing their faith. Their zeal and enthusiasm give new life and meaning to the entire denomination. The preamble to their constitution reveals their spirit of destiny and calling.

"This congregation must be viewed as an organism not an organization. The New Testament depicts the church as a body and a family. Both these illustrations

Seventh Day Baptists across the country with the organization of this new church. Rev. Mynor Soper brought greetings from the Missionary Society and challenged the new church to continue to move forward in the proclamation of God's Word in the great city of Memphis.

Pastor Bill Shoffner gave the response of the congregation to this welcome and expressed appreciation to all who have helped and prayed for this day. He stressed again that this was the beginning of a great work in Memphis and asked for continued prayer support of God's people for himself and the congregation as they face the challenges and opportunities ahead.

Prayers were given by Editor John D. Bevis and Rev. John H. Camenga. Also in attendance were the Rev. James Mitchell, Rev. Ralph Hayes and Rev. Floyd Goodson. Representatives were present from Christ Church, Little Rock, AR; Fouke and Texarkana, AR; Upper East Tennessee; Sunshine Mountain MS; and other areas as well. Following the worship and organizational services a reception was held in the adjacent church fellowship hall.

#### Church History

e began meeting here in Memphis on May 27, 1978 as a branch of Christ Seventh Day Baptist Church of Little Rock, AR. After a couple of months of meeting in a mobile home we stepped out on faith to rent this facility. With partial ad support from our mother church we began running ads in our community newspapers in different areas of the city and immediately began getting calls.

The Lord has blessed us with three feature articles in the morning newspaper's religion section. From these

we received contacts from as far away as Jackson, Tenn., and East Prairie, Mo.

Last Christmas we were blessed with being able to help two families with food baskets. This Christmas season we hope to at least double the number of families that we help.

Funding from the Missionary Society began on January 1, 1979 to allow Pastor Bill Shoffner to spend part time working for the church. A three-day crusade with the Soper family was held in June of 1979, preceded by visitation of about 350 homes in this neighborhood. During the crusade, as with all our special events, we took advantage of the free community announcement spots on the gospel radio stations.

We had a super SCSC team with us for five weeks this summer. They assisted with the Vacation Bible School, Youth Fellowship and visitation. We have received funding assistance for advertizing from the Women's Society and matching funds from the American Sabbath Tract Society for our fair booth and our listing in the telephone yellow pages.

The Milton, WI, church generously assisted our fair booth effort by providing attractive tract holders printed at our publishing house in Plainfield, NJ. The Lord led some 550 individuals to sign up for the Guide Bible course. There were many others who stopped by the booth to talk with us and take tracts. Follow-up has begun which is bringing additional contacts.

We of the Memphis church have truly felt the love and encouragement of our brethren across the country and we have certainly seen the Lord working. We praise Him for leading us to organize and we recognize that the work here is not over, but rather just beginning! -Sandy Shoffner

The church at Memphis had a most successful fair booth ministry at the Mid-South Fair. Although visibility was the chief aim of the project we were able to sign up over 550 individuals to the Guide Bible Course. There were also over 8,800 pieces of literature given out. In addition to this there were many opportunities to share our faith with those curious about Seventh Day Baptists.

In our follow-up letters and visits we have had several favorable responses and have one family attending church now from this type of contact. We were helped by the Milton church who supplied us with attractive tract holders. Also John Bevis, Jim Mitchell and Mynor Soper were able to come to town to help us for part of the fair.

With an attendance of several hundred thousand we see this as a very good outreach and are planning now for next year. This also gave most of the members of the church an opportunity to take an active part in the ministry and was a real blessing to each one as they made contacts with the visitors to the booth.

We truly feel the Lord worked through each of us and blessed us in this project.  $\Box$

There are so many voices screaming for many different interests in these days. Over TV, in publications, through direct mail appeal, these present so many good, vital and needed ministries.

MISSIONS I'm sure you find yourself, as I do, perplexed about which merit your attention and support.

Your Seventh Day Baptist Missionary Society faces the 1980's with great expectation and hope and prayer! God has called us to a tremendous task—the evangelization of the world—beginning at our own "Jerusalem"! We need to face God's challenge given in His Word. Our focus, our decisions, our ministry together must be based on the priorities which He has set, to the commission which He has given.

We see shattered lives everyday—people without confidence in tomorrow, broken people without hope. We feel an urgency to do something because as Christians we know there is hope (Romans 5:4-6). We have seen the gospel of Jesus Christ renew shattered lives. That's God's promise and our message!

During the last half of the seventies our priority was national missions. Statistics, recently shared by the teams visiting Associations and local churches, bore testimony to what God has given—at least 12 new churches and 25 new pastors! Compared with the 1965-74 decade of 2 new churches and 5 new pastors this indicates real and vital change. While the number of North American workers in International Missions declined in these years, the total number of national workers increased in sister conferences around the world and new doors have opened.

Now we face the eighties. This has been designated as a DECADE OF DISCIPLESHIP with the overall goal of "Double in a Decade"! During the first year—1980—we are committed to set our priorities and list initial goals. Our purpose has been set forth:

> "As Seventh Day Baptist Christians, we are called to glorify God and please Him in every way. This is done as we fulfill the Great Commission of our Lord. Our immediate objective is to discover and accomplish our mission—a commitment to growth. This means specific growth goals—for us as individuals, for our churches and for the ministry that we have to the world."

Our purpose can be highlighted in these three points:

First, "called to glorify God": This should be the highest aim of every Christian (Isaiah 60:21; 61:3; 66:5). This is done as we seek...

Second, "to please God in every way": seeking to know and do His will generally and specifically (Col. 1:10) and in...

Third, "fulfilling the Great Commission": We want to obey the Lord's command (Matt. 28:19,20) and make disciples.

These will be realized as we, each one, become true disciples. This calls for a spiritual life-style as shown to us by our Lord, Jesus Christ. Through "Decision to Discipleship" cell groups many are already involved in being disciples and becoming disciplers. We encourage each local church to foster at least one such cell.

#### FOUR MAJOR OBJECTIVES:

Objective 1: We want to win as many people as possible to Jesus Christ. Jesus said, "Herein is my Father glorified, that ye bear much fruit; and so shall ye be my disciples'' (Jn. 15:8),

Objective 2: We want to bless the churches, seeking under God to awaken, revive, and edify them; and to see the churches grow numerically and spiritually.

Objective 3: We want to see young people go into full-time service for the Lord. The church is in need of more full-time ministers, teachers, evangelists, missionaries.

Objective 4: We want to relate to the whole Body of Christ, sharing the Truth of the Seventh Day Sabbath which has

been so long overlooked or misunderstood, that countless others may "please Him" and know the joy of His Day.

#### OUR STRATEGY:

- Point 1: We work on a team with others-local churches, associations, Conference agencies, national sister conferences-the servant of all.
- Point 2: We seek to supplement and aid the ministries of others, offering leadership, insight, counsel, coordinating a united mission focus. This means initiative in areas of our country or the world where the purpose we have needs to be made known and the work of His Church begun.
- Point 3: We aim to minister in new fields-nationally or internationally-where doors open to relate to individuals, local groups of churches that seek fellowship, guidance and aid in a ministry of like faith.
- Point 4: We try to keep our staff to a minimum and multiply our ministry by cooperating with other Christian groups of like faith.
- Point 5: We offer specific conferences/retreats for pastors and church leaders and encourage their participation in inter-church training that will give insight and renewed vision and strategy for their task:
- Point 6: We look to God for the provision of funds in answer to prayer through local Seventh Day Baptist churches and Christian friends. If we are to fulfill these objectives we need regular monthly support.
- Point 7: We encourage every Seventh Day Baptist to become a voting member of the Missionary Society, indicating his/her vital support, giving his designated gift of \$10.00, and receiving regular reports of the work in the quarterly MISSIONARY REPORTER and special mailings.
- Point 8: We share information and facts on SDB missions through Mission Notes in the SABBATH RECORDER, special articles, a monthly mailing of "MISSIONS" to local church Keyworkers and Pastors, the annual Society report and visits to associations, local churches and General Conference to share and display facts. Special slide and cassette AV presentations are prepared and shared through the AV center of the Tract Society in Plainfield, N.J.

Will you pray for your Missionary Society's Board of Managers and the workers in the office and those on the fields—nationally and internationally? We look to God for His continued leadership and direction during this new decade! Pray for wisdom as we decide what doors to enter, where our limited resources can be best used, and as we expand on these methods for achieving these goals.

Decision to Discipleship can be the beginning of a lifelong experience in living for others. It aims to train an army of Christians committed to a life-style of discipleship.



## **DECISION**

"Decision"—an oft used word. It indicates choice. It shows action. It means movement in a specific direction.

While it is used in the phrase "decision for Christ" to indicate a definite commitment of an individual to Christ as Savior, it should also be used daily of the Christian who is called to "decide for Christ" and pattern his life to "Please God in every way."

You made a decision to read this *RECORDER*. This article. You are now deciding to continue or quit. We hope that by reading it through you will also sense the need for specific other decisions!

*IN YOU LIFE:* How can I better live for Christ? How can I use my own spiritual gifts to the glory of God? How do I know what gifts are mine? Have I decided to "open them"?

Will I seek God's leading to be helpful to at least one other person in his taking the step of commitment of his life to Christ? These are only a few of the many decisions that face us as individual Christians today. Not to decide is to decide!

*IN YOUR CHURCH:* Decisions are corporate too! Together with others we face opportunities and responsibilities. Thus it is important that church members join in the decisions that are theirs.

What goals do we have? How are these being carried out? How can more church members be brought into the ministry God has called them to do? Is my church meeting its responsibility in the community? —in the Conference? —in the ministry of SDB's through the Association, their missionary Board?

Could my church "mother" a new group in our area that it might become a core for a new SDB church? Are we willing to take the first step?

IN OUR CONFERENCE: Those attending General Conference at Adrian, MI, last August adopted the plan for a DECADE OF DISCIPLESHIP. This calls for us as a people to "Double in a Decade." What does this mean?

1. That each local church and individual needs to "buy into" the plan! Without this nothing meaningful will come to pass. It begins with *each* of us.

2. How can "Double in a Decade" become a reality in my church?

= 10% more in 1980 in Sabbath morning worship!

- = 10% more in 1980 in each Sabbath School Class!
- = 10% more in each Bible Study group! (in 1980) = 10% more in summer Bible School/Camping
- ministries! (in 1980)
- = 10% more in local church membership! (in 1980) = 10% more in "The Daily Walk" Bible
- reading! (in 1980) = 10% more in each of the youth fellowships! (in 1980)

= 10% more in the Women's Society! (in 1980)

= 10% more in our Men's Fellowship! (in 1980)

= 10% more in 1980 in.....

3. That we will increase our united giving to Our World Mission by 10 percent in 1980 (above inflation!) in support of our mutual ministries.

4. That Seventh Day Baptists together would seek to begin at least six new congregations in 1980—being organized into local churches. The USA map\* listed 12 places where SDB meetings are being held! One has already organized—Memphis, TN! There are at least 15 other places where open doors are waiting to be entered. Your church, your Association, your Missionary Society needs to respond to these opportunities!

5. That Seventh Day Baptists will encourage and pray for at least five new young people to respond to God's call to the ministry in 1980. We also need bi-vocational pastors to give leadership in many areas! Should we trust God for five such leaders in 1980? 6. That during 1980 a new couple respond to God's call to missions in another land, with others entering training to prepare for missionary service during the decade.


7. That as more missionary pastor churches become self-sufficient, at least one new field pastor enter into church planting ministries before mid-1981.

8. That during 1980 a "Decision to Discipleship" cell group will be started in every SDB church. Some churches began their cell in mid-1979 and some churches have two or more cells developing Disciples and preparing Disciplers.



## **KENYA MISSION VISITED**

Enroute to Malawi, Africa, Missionaries David and Bettie Pearson spent fifteen days in Kenya visiting Seventh Day Baptist churches and groups near Kisii. Organized as a mission of the Central Africa Conference, these churches have sought missionary leadership for over five years. A nine month term of service was given by Pastor Watson Mataka of Malawi, some years ago.



The Secretary of the Kenya SDB Mission is Joel L.O. Omare who has completed Bible School in Nairobi and seeks further education. Currently his employment in Nairobi hinders active regular participation in the churches since they are located over 200 miles west of the Capitol.



One of the larger groups is at Keore, led by Pastor George Babu. They have their own church structure, built like most of the homes in the villages in this part of Africa.



During the visit of the Pearsons the Sabbath service at Keore was held under the neighboring trees with a booth prepared for preaching. The youth formed a special choir on this occasion, adding a great deal to the worship experience.

While it seems, because of financial restrictions, the return of the Pearsons for a short-term ministry may not be carried through, it is hoped that encouragement and some visits of SDB leaders passing through Kenya can be arranged. The Kenya Mission was meeting in December to elect their officers for 1980. Pray for our brethren and their witness there.





• DECADE OF DISCIPLESHIP: Presentations were made by Director of Evangelism Mynor G. Soper at Blountville, TN, and Paint Rock, AL, on his Nov./Dec. field trip. In addition to spending two weeks with Field Pastor John Camenga on the NC, SC, VA and Eastern TN fields, he also visited groups in Western TN and AR.

• SOUTH AFRICA: James Siwane, the first seminary student from the Seventh Day Baptist churches in South Africa, completed his training at Albert Luthuli College of the Federal Theological Seminary of Southern Africa in November, reported Dr. B. Goba, the principal. Pastor Siwane has been given aid in his training by grants from the Joseph E. Lewis education fund, the SDB World Federation and New Fields/SSMO.

• MARYLAND, USA: The Central SDB church treasurer writes: "We have taken on Rodney and Camille Henry as our missionaries to the Philippines at \$30 per quarter. We see them as being our missionaries, not the missionary society's. We view the missionary society as the support clearing house. It is the plan of this program, upon reaching this \$30 goal (in each quarter), to take on other missionary outreach projects both abroad and at home (with additional funds raised). We would suggest the approach to other churches where the personal touch would bring personal responsibility."

• FULLERS RETURN FROM MALAWI, AFRICA: Menzo and Audrey Fuller returned on furlough in mid-December cutting short their service in Malawi by at least six months. This was one measure taken to bring expenditures in 1980 into line with anticipated SDB giving. Another is having the David Pearsons center their ministry in Malawi without further attempt to encourage the new SDB mission work with nationals in Kenya through a short-term field ministry.

• MISSIONARY PASTORS. USA: Accepting the challenge to assume 20 percent of the amount of support given their missionary pastor through the Missionary Society, the SEATTLE, WA, SDB Church is assuming full support in 1980. Thus they have met the aid given in their early years by the Pacific Coast Association and now that share through the Missionary Society. Most Missionary Pastor churches are planning to lower their asking for 1980 from the normal 10 percent to 20 percent, and COLUMBUS, OH, is setting its goal at 33 percent! Richburg, NY, completes its participation in this program, being aided for the ten year period.

• JAMAICA—CRANDALL HIGH SCHOOL: Principal Ronald Smith has submitted his resignation effective the end of Jan. 1980. The plan for reorganization of the CHS Board is planned for implementation by Jan. 1, 1980 with the Jamaica SDB Conference playing the leading role. In these days of change our brethren there need our faithful prayer support!

• NEW CONTACTS: "Where have you SDB's been the last 30 years?" Many new contacts have longed for a fellowship such as we have, but have only recently learned about us. For some it took real persistence. How will we respond to such need? While such contacts are referred to the closest pastor/church, many are in states or areas 100 or more miles from such. Director Soper is continuing to follow through on these, seeking to respond in every way possible on our behalf. Continue to uphold him and this ministry in prayer!

## MOVING-

"Toward The Mark..."

Dr. Elton Trueblood, in his extremely valuable work, *THE INCENDIARY FELLOWSHIP*, defines a committed Christian as one who has "a faith marked by a burning conviction and the consequent desire to see it spread." He then proceeds to challenge modern Christians to begin a "movement" that will have as its ultimate goal a church alive with the fire of God's love and purpose. This will be discovered, he writes, as Christians become part of that movement: "The renewal of the Church will be in progress when it is seen as a fellowship of consciously inadequate persons who gather because they are weak, and scatter to serve because their unity with one another and with Christ has made them bold."

Seventh Day Baptists have the opportunity—or might it better be said, the obligation—to participate in such a movement. We have our convictions and they are based on a clear understanding of God's Word and purpose. And from that Christian perspective we are being called to enter into a Decade of Discipleship. We are challenged to become disciples—to "please God in every way." We have had put before us a goal—double in a decade and with God's help and our common strength in the unity of His love we can achieve it.


We are embarking on a movement. The dictionary definition is simple: A movement is "a series of organized activities working toward an objective." Our objective, as it ought always to be, is to bring other people into a unique disciple relationship with Jesus Christ to assist them in their Christian walk until they, too, can become reproducing Christians. As we "go from one point to another," as we "take action," as we "make progress," we are all called upon to participate. A movement, unlike a program, begins slowly, develops strong leadership, has recognizable and reachable goals, and presses on, in the words of the apostle Paul, "toward the mark of the high calling of God in Christ Jesus." Such a movement is being launched today, and Seventh Day Baptist Christians are invited to become a part of it.

Movements are not uncommon to Seventh Day Baptists. In 1919 we launched what was then known as the Forward Movement—a unified benevolence program that, within the five years it was encouraged, increased giving by 222 percent. It took time, it took effort, but it was successful because the people responded to the strong leadership that carried it through. Between the years 1959 and 1964 Seventh Day Baptists participated, with other Baptists, in the Baptist Jubilee Advance, and our people saw the need to build upon the faith that is ours and seek new avenues of service and participation.

And now we launch the "Decade of Discipleship." It is significant that our Conference president has challenged us with the theme: "Pleasing God in Every Way."

It focuses our attention on the fact that as Christ's disciples we are to be living the life-style of  $\hat{a}$  disciple. We are to live as Christ lived. It is interesting to note that the Greek word that is translated into "pleasing" is the same word that from the Hebrew is translated in the Old Testament as "walking with." We read that Enoch walked with God, that Abraham walked with God, and that David walked with Him. They "pleased God in every way" and their stories are recorded in the long list of those whose faith is encouragement to our own in Hebrews 11. Pleasing God is walking with Him. And walking with Christ in God is a movement—a step forward. Paul was visiting with the thinkers on Mars Hill and informed them that in God "we live, and move, and have our being." When we live for Christ, when we please Him in every way, we move toward that ultimate relationship-eternal life with the Father.

We are fortunate to be given the opportunity to participate, as Seventh Day Baptist Christians, in a new "forward movement" that leads to a new objective double in a decade. We can do it. Our convictions are such that we can see the future out ahead of us. When we draw near to God we have the promise that He will draw near to us and lead us in each new step forward. The call is for us to move ahead—to follow in Christ's footsteps, to advance into new tomorrows of trust and faith. Join together, Seventh Day Baptists, in a new (continued on page 28)

## MISSION TO CHINK

## The Great Years Part 3

Our mission in China continued to grow during the second dozen years of the 20th century. Although the world was involved in its first great war, our mission was affected only indirectly, and although our mission school children did participate in a growing national student protest movement, domestic affairs on the mission field also were relatively calm.

Our congregations doubled in membership, adding an average of ten members per year by baptism. Our boys' and girls' boarding schools kept stretching to accomodate more students, but the constantly overcrowded conditions led to plans for new school buildings. And the new hospital at Lieu-oo steadily gained the confidence and patronage of the community, which was not used to in-patient care.


Our mission was staffed by the D.H. Davises, who had just returned to China from leave in the United States, the Jay Crofoot family, the Doctors Palmborg and Crandall, and the recently arrived Anna West. Susie Burdick was in the United States on furlough.

In 1913 the demand for a Western education had become so great that the boys' school was turning away applicants and a new mission dwelling was constructed next to the chapel so that the girls' school building could be devoted exclusively to instruction.

Mr. Crofoot took the opportunity of the 25th anniversary of the boys' school in 1914 to organize an alumni association and to begin a campaign for a new, larger building. The work in the girls' school was bolstered by the return of Miss Burdick, and some of the older school girls began to receive training and practice in teaching Sabbath school.

Just months after a special celebration of his 70th birthday, D.H. Davis was dead, having served 35 years as a missionary to China. Fortunately, the veteran missionaries, the Eugene Davises, were ready to return to China, so they could step in very shortly after the death of D.H. Davis, and the elder Mrs. Davis remained with the mission entirely at her own expense, assisting in any way that she could.


Mr. Davis' influence as pastor-administrator soon began to be felt in the Shanghai church, as he successfully proposed a more formal church organization with officers, deacons and deaconesses, and as he won acceptance for an annual budget and systematic giving.

Like his predecessors, Eugene Davis received many requests for his time and talents outside of the mission, and he was now involved in teaching Bible classes in several Chinese institutions. He also continued to strengthen the life of the Shanghai church, instituting frequent fellowship and business meetings to increase the support and participation of the congregation in mission activities.

In 1919, Mrs. D.H. Davis finally was forced to permanently leave China because of serious illness, but not before the Shanghai congregation gathered to celebrate her 70th birthday. Anna West was in the United States on leave.

Seventh Day Baptist students began to demonstrate political awareness as they joined a general student strike throughout China to protest government corruption and Japanese aggression. Talk about a new boys' school building was replaced by action as Mr. Crofoot appealed to American Seventh Day Baptists for \$10,000 after securing pledges of \$1,700 from the school's alumni.

Conditions remained unsettled in 1920 as the student strike movement grew and as the mission faced more personnel changes. The Crofoots were forced to depart in haste so that Mrs. Crofoot could undergo emergency

which climaxed at Adrian. The associated Conferences went smoothly with efficient directors working with children and youth.

There were many problems with the youth evening activities; poor communication with college personnel and mosquitoes being foremost.

The board's program presented at General Conference emphasized the need for the quality of many of our Sabbath Schools to be improved. We thank Ethel Dickinson who wrote the script and the young people who participated "actively" in the program. It is hoped that those persons who have the responsibility of administering Sabbath Schools will carry out some of the suggestions offered in that program.

The recommendations from General Conference have been received and the various committees are working to develop the changes necessary. The Life Ventures Committee is working on a bibliography of books which will be useful for Family Worship. This list will be published in the April Sabbath Recorder.

The Junior High Nurture lessons have been sent to the publishing house and will be ready for use in the near future. These lessons will help the youth be more knowledgeable about the Sabbath and ways to keep it according to God's plan.

The Resource Development committee has accepted the resignation of Rev. Albert N. Rogers, editor of the *HELPING HAND*, who will complete his series of lessons with the September - November 1980 quarter. The committee is searching for another writer for the *HELPING HAND*. Many letters asking that the *HELPING HAND* continue to be produced have been received since the recommendation of the Conference Communication Interest Committee.


surgery at the Mayo Clinic, but their departure was offset somewhat by the return of Anna West, who was accompanied by her mother Nettie. Although Nettie was never actually employed by the Missionary Society, she proved to be a most helpful member of the mission family.

The Shanghai church ventured into a new ministry with a Children's Church, the mission students began an annual involvement in a 300-voice community chorus at Christmastime, and some of our school girls found joy in serving others as they used some of their own time to tutor children who could not afford education.

January 1980

In 1921 the Crofoots were able to return to China and they brought with them yet another West woman, Anna's sister Mabel, and Susie Burdick took leave in America. Meanwhile, the building campaign grew as the girls' school launched a fund drive and the mission purchased an adjacent tract of land. In spite of annual increases in the Shanghai church's budget, it was continually oversubscribed. The church also established a Junior and Senior Christian Endeavor and offered Daily Vacation Bible School for the first time. The Lieu-oo church now also became more formally organized, but native leadership problems hampered its growth. (continued on page 28)





The open door is before us...the beginning of a new decade. The same immense question faces all of us...WHAT DOES THE FUTURE HOLD...For us as individuals; for us as a human race? Without Faith in God and His purpose for us, we dare not even consider the future. We weep for those without the guiding light of Jesus Christ in their lives.

Many years ago, during wartime, when our land was "blacked-out" at night for fear of enemy attack, our family was in process of moving several hundred miles to a new location. It was so dark in the towns and villages through which we drove that we were never sure where we were. One such night, in a search for lodging, we got out of our car, and going to the building, we had to feel for the front door, to find the bell which would summon the proprietor. After being admitted, we were not allowed any light except a single candle to prepare for the night, and we were cautioned to extinguish it as soon as possible. We put our children to bed, and we laid down without undressing, sleeping fitfully, without real rest, for the duration of the night. When daylight came in the morning it seemed like a glimpse of heaven to us. We had never before realized how wonderful the sunshine in a small country town could be, and we witnessed the beauty and drama of the world around us with deep joy. All shadows were driven away, as well as a fear of the unknown. What a miracle is light!

The "Light of the World" gives us all we need to prepare us for the 1980's. Not only does this guiding light cast out our fear of darkness of the future, but it brings purpose to our lives. Jesus' love is persuasive. He treats us as if we were what we ought to be, then gives us the power to fulfill our possibilities. Jesus' love is joyful...not based on emotions but is an immeasurable sense of goodness, of realizing our blessings, no matter what our circumstances. Not only does the light of Christ cast out fear, give us purpose and power, and fill us with joy, but it is a challenge. Just as He said to Simon and the others, He says "Follow me." He does not stand and give us directions; "Go down route 25 until you hit 80, then travel along until you come to the turnpike..." He says, "Lo, I am with you always, even to the close of the age!"

How can we fear the future with such a light to guide us?

Could you take a Journey of Love that lasts a week, sometime during the beginning of this year? It is a simple exercise and it might just start us on a journey that will last for the whole decade...

The day by day Journey of Love...

The First Day: THE HAND OF LOVE: On this first day we will write to someone we haven't written to for a long time, (not a relative) expressing appreciation for his/her friendship.

The Second Day: THE VOICE OF LOVE: We might telephone some one or two persons with whom we seldom have a chance to visit, telling them we appreciate them and expressing our Christian love for them.

The Third Day: THE DEED OF LOVE: On this day we would take something we have made (perhaps food), or grown (a plant), to someone to whom we rarely express our love. Perhaps our gift might be a book which is a favorite; one we know the person will enjoy.

The Fourth Day: THE HEART OF LOVE: On this day we would pray for some one person to whom we need to relate in a more loving way; perhaps there is a barrier to break down. Pray for that person several times that day, and then think of something to do for him/her.

The Fifth Day: THE MIND OF LOVE: On this day we read a whole book from the Bible, looking honestly and critically at ourselves. This is a time to think of ways to improve our Christian witness. Here is a time to rid ourselves of those things which come between us and others.

The Sixth Day: THE LABOR OF LOVE: On this day we might go into a home where we know we may help someone who needs help. Perhaps it would involve taking care of a child so the mother might have a few free hours. There are many who need loving hands to do things for them that they are unable to do for themselves.



#### SDB WITNESS AT THE ALABAMA STATE FAIR

BIRMINGHAM, AL—When one thinks of going to the brightly lit annual Alabama State Fair in Birmingham, he not only thinks of the joys of riding the dashing attractions (even an elephant ride was featured), but also of the pleasure of casually walking along inside the attractive exhibition hall. There were many displays ranging from candy sales to church booths with numerous items of interest in between.

This year's fair attendance in October consisted of 324,914 paid admissions. This means literally thousands of persons passed by our Seventh Day Baptist-Bible Sabbath Association Booth. Many stopped by to pick up tracts or ask questions, 102 signed up for the Guide Bible Course. We praise the Lord for this!

Put the payment for the booth (ours was \$200) into the church budget ahead of time and assign those persons (or person) to the various tasks of carrying out this effort. One person should have general responsibility for the booth.

Make sure *early* to notify your state fair authority exactly which location you choose for your booth and choose one near a door or where many people will likely pass by.

Advertize your booth in a local newspaper ahead of time; try to get the religious editor to mention your booth in his column; contact the Bible Sabbath Association for additional helps.

Set up your booth attractively and in the background develop an appropriate Biblical theme. We had tables to display our literature and chairs for the weary to rest while they watched a twelve-minute casette/ slide presentation on "The Sabbath."

You might wish to feature some of the following in your fair booth. Having people register for a free Bible course, give free balloons with your church name and address imprinted, give out comic-type gospel tracts along with hard candy to children, distribute the current Bible Sabbath Association Sabbath Calendars, comfortable chairs and perhaps cool water. I would suggest with the free water a small sign to read, "I am the water of life" and let this be





About three hours later, around 2 AM, Karen awoke with a temperature of 105. The nurse said she would have to give Karen a cool bath. As she quickly got some water, I asked, "She will be all right, won't she?" There was no answer, so I asked again but still got no answer. Karen's little body was so hot and her eyes were barely open as she reached out for me. As I bent down and hugged her, I couldn't help wondering, "Was it going to happen this quickly? What would I do without her? What would I tell David?"

The nurse had given Karen some medicine to help bring her fever down before she gave her a bath. About a half hour later the fever came down to 103. I knew she was still a sick little girl but it made me feel better. As the nurse finished taking her temperature, she noticed Karen's IV had come out again. I wanted to cry out loud, "Please, not again?" After Karen left the room to get her seventh IV, I started to cry, and I knew my only hope was in Jesus. I reached for my Bible and opened it. It fell open to Psalm 34:4. In the Living Bible it reads: "For I cried to him and he answered me. He freed me from all my fears."

As I read that verse I remembered something that a dear, sweet sister in Christ of mine had told me. She said that along with her walk with the Lord, she realized that she wasn't to worry about her children. She was to give them to God. She told Him they were His children and she knew He would take care of them and with that she didn't worry about their every little move. She knew God had them in His care.

As I thought about that, I got down on my knees and prayed by my cot, "Dear Lord, I can't handle any more of this night without you. I love Karen so much, she is so small, she doesn't even understand what is happening to her. Lord, I know the devil has done his best to upset me and make me doubt you. And for my lack of faith I ask you to forgive me and help me to always come to

The completion of a new auto road between Shanghai and Lieu-oo in 1922, the high cost of real estate in Shanghai, and the lack of mission schools in the Lieu-oo area, prompted the mission personnel to consider establishing the new boarding schools in Lieu-oo instead of Shanghai. In 1923 Susie Burdick was back in China, but the Eugene Davises were on leave in America.

And in 1924, it was the end of the second dozen years of the new century: the Crofoots celebrated their 25th anniversary as missionaries to China; the churches were growing; the schools were looking toward new buildings and an enlarged work; and the era of the lady doctors was drawing to a close, as the mission prepared to welcome its first male doctor, George Thorngate, and his family. Truly these were "The Great Years!" (NEXT MONTH—"The Great Years, Part 4")

I had just gotten up and was sitting on my cot when the nurse brought Karen back into the room. She said she had good news this time. She felt good about this IV staying in until morning. Karen's temperature was down to 102. When I put her into her crib, she went to sleep right away. I said a little prayer of thanks in my heart and then I lay down too.

When I woke up at 7 AM, I couldn't believe Karen was still asleep. Karen stayed in the hospital for seven more days. We were so thankful the day we brought her home. And we are still thanking God for the way He has taken care of her.

Karen has been in remission (there have been no cancer cells) for ten months. She had radiation therapy every day for three weeks at the University of Pennsylvania Hospital. 





About three hours later, around 2 AM, Karen awoke with a temperature of 105. The nurse said she would have to give Karen a cool bath. As she quickly got some water. I asked, "She will be all right, won't she?" There was no answer, so I asked again but still got no answer Karen's little body was so hot and her eyes were barely open as she reached out for me. As I bent down and hugged her, I couldn't help wondering, "Was it going to nappen this quickly? What would I do without her? What would'I tell David?"

The nurse had given Karen some medicine to help bring her fever down before she gave her a bath. About a half hour later the fever came down to 103. I knew she was still a sick little girl but it made me feel better. As the nurse finished taking her temperature, she noticed Karen's IV had come out again. I wanted to cry out loud, "Please, not again?" After Karen left the room to get her seventh IV. I started to cry, and I knew my only hope was in Jesus. I reached for my Bible and opened it. It fell open to Psalm 34:4. In the Living Bible it reads: "For I cried to him and he answered me. He freed me from all my fears."

As I read that verse I remembered something that a dear, sweet sister in Christ of mine had told me. She said that along with her walk with the Lord, she realized that she wasn't to worry about her children. She was to give them to God. She told Him they were His children and she knew. The completion of a new auto road between Shanghai and Lieu-oo in 1922, the high cost of real estate in Shanghai, and the lack of mission schools in the Lieu-oo area, prompted the mission personnel to consider establishing the new boarding schools in Lieu-oo instead of Shanghai. In 1923 Susie Burdick was back in China, but the Eugene Davises were on leave in America.

And in 1924, it was the end of the second dozen years of the new century: the Crofoots celebrated their 25th anniversary as missionaries to China; the churches were growing; the schools were looking toward new buildings and an enlarged work; and the era of the lady doctors was drawing to a close, as the mission prepared to welcome its first male doctor, George Thorngate, and his family. Truly these were "The Great Years!" (NEXT MONTH—"The Great Years, Part 4") I had just gotten up and was sitting on my cot when the nurse brought Karen back into the room. She said she had good news this time. She felt good about this IV staying in until morning. Karen's temperature was down to 102. When I put her into her crib, she went to sleep right away. I said a little prayer of thanks in my heart and then I lay down too.

When I woke up at 7 AM, I couldn't believe Karen was still asleep. Karen stayed in the hospital for seven more days. We were so thankful the day we brought her home. And we are still thanking God for the way He has taken care of her.

Karen has been in remission (there have been no cancer cells) for ten months. She had radiation therapy every day for three weeks at the University of Pennsylvania Hospital.
