# STAND FIRM

Last month we looked at the need to put on God's armor to stand firm against the wicked schemes that the evil one has planned against us. You can't use worldly weapons to fight a spiritual battle. The Bible says, "The weapons we fight with are not the weapons of the world. On the contrary, they have divine power to demolish strongholds." (2 Cor. 10:4) The reason they are powerful is because they are, in fact, God's nature and character. When we reflect the image of God it is because we are becoming more like Him in our nature and character. What is the armor that we have been commanded to wear? It is Christ Jesus Himself. When we put on Christ, we truly can stand against every strategy of the devil.

It has been taught that the apostle Paul was using the equipment of a Roman soldier as his model to talk about God's armor. However, Isaiah the prophet, who wrote hundreds of years before the Roman empire was born, uses almost all of the same words for the full armor when talking about God. "He put on righteousness like a breastplate, and a helmet of salvation on His head...and wrapped Himself with zeal as a mantle. (full armor)" (Isaiah 59:17)

There are many parts to the armor of God. This month we take a look at the first three — truth, righteousness, and the good news of peace. The only way to be able to stand firm entirely is to have been fully equipped with God's armor in place. Without these firmly in place, the evil one has options available to push us off our devotion to God and dedication to His will being done in our lives.

## Truth, Righteousness, and Peace. Where do these come from? They come from God.

All truth comes from God because God is truth. That doesn't mean that a person who does not know God is incapable of understanding things that are true as opposed to false. What it does mean is that truth is not an abstract concept. Truth is a person. We know what is true because Jesus Christ is truth. He said that He is "the way, the truth and the life." (John 14:6)

Righteousness comes from God because God is righteous. "He is holy." We know what is right because God is right. He is the standard by which we understand righteousness. Peace comes from God because God is peace. Peace is not the absence of war. Peace is in the presence of God.

"Therefore, take up the full armor of God, so that you will be able to resist in the evil day, and having done everything, to stand firm. Stand firm therefore, having tightly wrapped your waist with truth, and having put on the breastplate of righteousness, and having perfectly fitted your feet with the preparedness of the good news of peace;" (Ephesians 6:13-15, NCAV)

#### Truth

The waist area which especially needs strength is the lumbar area up until the 5th vertebrae. A belt was wrapped tightly around the lower waist in order to give the ability to exert maximum pressure. When lifters are moving heavy furniture they have a belt that they wrap tightly around themselves in order to keep safe and to do the heavy lifting. The lumbar region is especially vulnerable to injury when a large force is exerted.

Figuratively, this phrase means "to be ready for anything." To be ready for the attacks of the evil one, we must have truth firmly wrapped around our areas of vulnerability. We cannot have a casual approach to the study and application of God's word and still be prepared for the evil assaults which come our way. We must tightly wrap the word of truth around us.

The phrase "having tightly wrapped your waist with truth" is actually an imperative command. Too often we treat the learning and application of God's word passively. In order to be ready we cannot be passive. There are two ways in which we can be actively prepared. The first is to be an active listener during Sabbath morning messages. An active listener recognizes this truth — that the Lord has something that He wants us to apply to our lives through His word. As it says in James, "Do not merely listen to the word; do what it says." We should be asking the Lord each Sabbath morning for at least one action step that He wants us to put into practice. The Lord is our shepherd. He has a plan to lead us to green pastures and still waters. We should anticipate His leadership and be ready to apply what He gives us.

The second way we can be actively prepared is to talk with others about God's word. There is a large difference between the listening that goes on during a sermon and the conversation about the Bible that takes place in a small group study. We cannot expect to be prepared

with truth to the same level if we are not talking about it and studying it and applying it with others. When we are challenged to put God's word into our own words the impact is huge. It is a joy to worship with others in a large group. This is an important part of being a part of God's body of believers. However, from the beginning God's people have met in homes or smaller groups to learn, to fellowship, to worship, to pray, and to be led by the Spirit. When we are missing out on these smaller gatherings it impacts our ability to be prepared with truth.

#### Righteousness

Just like body armor which protects a soldier's vital organs, righteousness protects our heart or the core of who we are in Jesus. Righteousness has a two-part meaning. The first is the righteousness of Christ which is given by faith to those who trust Christ alone for salvation from sin and its consequences. This righteousness is absolute. It is 100% purity due to the fact that Jesus was without sin. Some don't believe that it is possible to impart righteousness, but the Bible is clear in its teaching. "He made Him who knew no sin to be sin on our behalf, so that we might become the righteousness of God in Him." (2 Cor. 5:21) God's righteousness cannot be reached through human effort. In fact, "all our righteous deeds are like a filthy garment." (Is. 64:6) In order to be protected from the attacks of evil, we need to be given God's righteousness, and this comes only through faith in Jesus Christ. "The righteous will live by faith." (Romans 1:17)

The second meaning of righteousness is doing what is right. Although we in our human ability cannot be 100% righteous, we know that there are right things to do and wrong things. It is right to tell the truth. It is right to honor our father and mother. It is right to keep the Sabbath holy. When we value and honor God's standard of righteousness, we understand what is the right thing to do.

We live in a spiritual battlefield. Our heart, which is the central core of what guides our life, is constantly under attack. Proverbs gives this wise advice, "Guard your heart, it is the wellspring of your life." The evil one seeks to move us toward accepting and living by a human standard of righteousness instead of God's timeless standard. We are prone to slide into using the world's definition of right and wrong. We need to keep God's righteousness firmly in place so that our hearts can be kept from gravitating toward human standards of righteousness.

#### The Good News of Peace

The footwear of a soldier provides a solid foundation on which to fight. Firm footing is essential to standing firm in the middle of a struggle. In the same way the good news which leads us to a relationship with God is the foundation upon which our new life is founded. True peace can only be found through Christ who is the Prince of Peace. The fruit of the Spirit of peace is the overflow of peace that comes from the presence of the source of peace, God himself. The Bible says, "Therefore, having been justified by faith, we have peace with God through our Lord Jesus Christ." (Romans 5:1)

We can only stand firm when the foundation upon which we stand is secure. Is your foundation secure? Do you know beyond a shadow of a doubt that if you were to die today that you would be with Jesus forever? Are you 100% sure? The good news is that you can be sure. You don't have to wonder about it. You don't have to try and guess whether or not you measure up to God's standard. You don't! But you don't have to be 100% righteous and holy in order to know your relationship with God is secure now and into eternity. Jesus can be your righteousness. You can have peace of mind today by knowing that you have been made righteous or justified by faith in Jesus. Your peace of mind comes from being at peace with God when the Prince of Peace enters your life. 1 John 5:11-12 states, "And the testimony is this, that God has given us eternal life, and this life is in His Son. He who has the Son has life; he who does not have the Son of God does not have the life."

This is a paradox. The gospel of peace brings preparedness to stand firm in our struggle against the evil one. "It is the appropriation of the gospel of peace which makes one ready for war." (p.449, WBC, Lincoln) The peace of God is powerful. "The God of peace will soon crush Satan under your feet." (Romans 16:20)

#### Stand Firm

How can we stand firm against the work of the evil one in our lives and in our time? We must actively clothe ourselves with truth, righteousness, and the good news of peace. We cannot stand firm by using the tactics of the evil one but instead must learn to resist according to the weapons of God's fighting. In Him we are strong. In Him we overcome all of the strategies of the evil one.

# Truth, Righteousness, and Peace

#### Spiritual Warfare in Iglesia Bautista del Septimo Dia Puerto Rico



The second annual youth camp of the Agape Ministry Iglesia Bautista del Septimo Dia in Puerto Rico (Seventh Day Baptist Church in Hoyamala, San Sebastian, Puerto Rico) was held July 13-18, 2015. There were lots of great moments, but the highlight came on Thursday evening, July 16, when we saw the Holy Spirit move and take back His territory and His people.

All week until then, there had been spiritual struggle. The camp cook brought her sons and their behavior deteriorated as the week went on, bringing a spirit of confusion and frustration into the camp. Adding to this situation, some of the adults helping with the camp were unable to stick to the schedule or to provide needed support. The arts and crafts director (from a neighboring church) harshly criticized one camper's efforts to the point of creating hurting feelings and disappointment. Some campers were listless and rebellious — almost defiant. One camper in particular (Wills) was disaffected and began repeating "I want to go home" as early as Tuesday. His behavior began to affect the other campers as the week went on.

Tuesday night, July 14, was a great spirit-filled evening service where youth ministered to youth and were in turn ministered to by adults. The speaker laid hands and prayed, ministered, and prophesied over the youth. But by Wednesday afternoon, the disorganization and rebellion were creeping back into the camp. Wills again stated his desire to go home and was starting to try to recruit other youth to leave the camp. The situation continued as a sort of tug-of-war between organization and chaos until Thursday evening.

One of the youth, Ricardo, had stated before camp that he wanted to get baptized and that celebration was scheduled for Sabbath morning service. But, with the inability of the Berlin, NY, team to be present, and with the struggle going on, a last-minute change was made and the decision taken to baptize Ricardo Friday morning.

When the Thursday evening meal was bordering on chaos, Pastora Judith felt in her spirit that Satan was getting hold of the campgrounds and of some of the campers. As she quietly prayed for wisdom, she was able to discern a whirlwind of destruction and mockery. Immediately she got hold of Ricardo and told him that his baptism was going to be in minutes. She

asked brother Craig Mosher (he was going to help with the baptism the next day) to get into the pool immediately. Without any hesitation he did and she followed. Immediately Ricardo followed. She announced that in order to kick Satan in the teeth, we were going to baptize Ricardo that night — that moment. The mood changed. Peace came over the dining area, over the campers, over the leaders, over the missionaries helping out. The Pastora had gotten their attention and so had God. As Ricardo's baptism was completed, Pastora asked if there was anyone else that felt led to get baptized. There was calm; there was a never-felt peace near the pool. Pastora explained it as if the Lord Himself got in the water with her. Immediately a young lady came forward crying, "Dei." She said she wanted to get baptized, then Erick came forward stating that he too wanted to get baptized and then Justin, the 10 year old boy and first attendee of the church three years ago. Then came the moment the Pastora was waiting anxiously for, Wills (the young man being used by Satan to help him bring chaos into the camp) came over and told the Pastora, "I caused all these problems all week long just to end up under the water; I too want to be baptized."

As Wills went under, we could all sense a "second wave of the Holy Spirit," a lifting of a heaviness, and a sense of peace and complete order being restored. In all, five young men and women were baptized: Ricardo, Justin, Dei, Wills, and Erick. Needless to say, the atmosphere from that moment on was one of cooperation and enlightened peace. The dramatic change in the mood was not lost on the youth. We want to focus on Wills' response to the events of the week: "All this, just to end up being baptized." It is called "God's everlasting love."

As the 2015 Youth Camp came to an end, the church membership had grown by three new members. Two of the newly baptized are still taking discipleship classes and hopefully they too will join the church — among them is Wills.

To God, indeed, belongs the victory, the glory, and honor. Praise His name.  $\overline{\mbox{SR}}$

Recently, my good friend, Ann, and I started to include *Ned in some of our activities. We knew from what neighbors* told us that Ned had lost his beloved wife just a year ago and was still in the grieving process. So to help alleviate all the meals eaten alone, we started to invite Ned to join us in some of the evening meals we shared now and then. Both Ann and Ned were avid movie watchers, so about once per week we arranged "dinner and a movie night."

After a few of these get-together meals, I began to be offended and somewhat upset by something Ned said at least once per evening. I thought he was insensitive, self-centered, and thoughtless now and then. After one such evening, I found myself texting Ann that I didn't think I would be participating in events that included Ned any more. I wanted to keep him "at arm's length" and avoid conversations with him as much as possible.

Ann encouraged me to talk to Ned about the remarks I found upsetting instead of avoiding him. So, realizing that my Christian witness was on the line with these two friends, I responded to her wise and gentle push by saying I would pray that God would provide both the opportunity and the words to talk to Ned. This "talk" had to happen within a few short days, as Ann was already planning our next dinner and a movie night for that weekend. The next morning I saw Ned outside, walking around his house and I considered going over to talk to him. However, a clear thought came into my mind, "No, I will bring him to you." I recognized that as a direction from God and did not go over.

A day later, I was driving home, not paying any attention to the time. I was hungry for some supper. It had been a long day. I was not up to the effort of cooking my own meal in the kitchen at home. On impulse, I pulled into a pizza place on my route, and ordered a Hawaiian style pizza to go. After paying for it, I sat outside, occupying myself until the pizza was done and my order was up. At least twenty minutes went by, and most likely more, when I finally realized that folks who had entered the pizza place after me were now walking out with their food to go. So I stepped inside to find that my pizza was up and ready.

Continuing to drive home with the pizza, I saw Ned coming down our street in his vehicle. Our cars met just outside my driveway and I rolled down my window to wave. I apologized for disturbing them, and explained my situation with the bee sting. When I asked for a cigarette in order to use the tobacco, Ed graciously produced one. His response was swift and caring. I thanked him and was on my way.

At home, applying the tobacco to the bee sting area and securing it with a band aid, I thought about how God had that very afternoon reminded me of Ed's name just hours before He knew I would need it. Once again I was reminded that God is good all the time, and His timing is perfect as He cares for us.

#### FROM ASHES TO JOY

"Our old house burned down." Thus my husband greeted me one frigid January day in 2014.

With shock and dismay, we drove to view the damage. The roof, held in place by 170-year-old timbers, was intact. But between those timbers was empty charred space where our children's bedrooms had been. We had bought the handyman's special as newlyweds, brought our new babies into it, and spent most of 25 years making it as comfortable and presentable as the budget would allow. Then in 2000, with a son in South Korea with the Air Force and a daughter starting her final year of college, we found a charming Tudor-style house in town — smaller, 100 years newer, and closer to our jobs and the pharmacy.

Energetic young parents of a two-year-old were excited to buy our old farmhouse and began to renovate it, hoping to fill some of the four bedrooms with more children. The tired old house took on new life under their regime; the empty bedrooms did not.

We grieved the new owners' loss as well as our own sweat equity and were greatly relieved to learn that the blaze was not a result of any of our amateur electrical projects.

The community rallied around the family who had been left with a garage, two dogs, a rabbit and hutch, a mailbox, two bikes, and a sundial. Fund-raisers were held and household goods were collected. A temporary home was offered from someone's estate.

In a few weeks' time, the charred timbers became a pile of rubble which mercifully was bull-dozed. Grass was

planted on the site and a new septic system replaced our three cesspools, satisfying the township code.

The family celebrated our Savior's birth in a brand-new rancher on the spot where I had once hung diapers every other day. Speaking of diapers....a brand-new baby daughter joined the family mid-way through the ordeal — joining her 16-year-old brother!

As I ponder the events of this tragedy and new life, I am reminded of God's promise...to give unto them beauty for ashes, the oil of joy for mourning..." (Isaiah 61:3b KJV).

The idea of participating in SCSC was briefly brought up by a friend and that was all it took for the seed to be planted. All throughout 2014 the seed grew and I couldn't deny the calling God placed on my life. I listened to the call and submitted my application.

From the very beginning the whole adventure of SCSC has been a growing experience for me. Stepping out of my comfort zone was hard for me from the start. As the weeks continued I was thrown into new roles and environments I had never experienced before.

This year our theme at training was "Identity." We learned that our identity is formed in Christ and not in our own self-perception. This was an important theme for us to study and take the time to discuss because it is something that we all can struggle with at times. Not knowing who we are in Christ is the easiest way for us to lose our way.

God has been teaching me about my identity through training for leadership and learning what that really means. Expanding on my experience of learning with leadership, I learned that God may call me to do something out of my comfort zone and I will have to rely on Him even more. Learning to let go of pride, becoming a servant leader, and letting God take control in whatever I'm doing is a lifelong pursuit.

I had to get it through my head that my will power was not going to cut out the sin in my life and that I had to accept God as my identity, claiming His things as my own in order to leave the others behind. 

Contrary to popular belief, being a teenager is hard. The Bible is full of scripture that tells us to give everything to God rather than be in a constant state of stress. Psalm 55:22 says, "Cast your burden on the Lord and he will sustain you; he will never permit the righteous to be moved." We see something similar to this in Philippians 4:6-7: "Do not be anxious about anything, but in everything by prayer and supplication with thanksgiving let your requests be made known to God. And the peace of God, which surpasses all understanding, will guard your hearts and your minds in Christ Jesus."

So as the school year progresses and you find yourself being overtaken by standardized tests, college essays, sports, volunteer hours, homework, and whatever else you may be involved with, remember, you're not alone. Today my friend and I were coming out of our biology class and we were greeted by a "lovely" heavy rain. All we could think about was how we were going to get to our next class across campus. Neither one of us had brought an umbrella and we had left our jackets in my car. We had heard a rumor that it might rain but neither of us had really believed the reports. So, needless to say, my friend and I ran out into the pouring rain to our next class attempting to shield ourselves with our binders. Of course, when we got to our next class we were both soaked from head to toe and shivering because the building's air conditioning was on. (It had been hot earlier that day.) At the time, all my friend and I could think about was how miserable we felt. But it is November the time of the year that we set apart to think about the blessings we have and what we can be thankful for! Since its time for thanksgiving, we are going to do a little exercise together. I want you to think of a random event that happened to you within the last few days — one, that at the time, seemed more negative than positive (as I did above). Go ahead and think about it — I'll wait.

Got one? Awesome. Now I want you to flip that event on its head. How were you blessed by the event? What are you thankful for after the event occurred? 1 Thessalonians 5:18A (ESV) says, "Give thanks in all circumstances...." So

that is what we are going to do. What happened in my event that was a blessing? Well, let's start at the basics: I thank God for the rain that we so desperately need in California right now. I thank God that when I did not have my umbrella I did have somewhere to run to in order to shelter from the rain. I thank God that, a few days after this, I have not gotten sick. I thank God that rain only lasted about an hour or so, and my friend and I were able to run to my car and get our jackets after class. And I can even look at the fact that I had my binder to help shield me, because I probably would have been a lot more soaked if I had not had it. These are just a few examples of the blessings that were hidden in what I at first thought was an annoying inconvenience.

So what can you do with this? This is an exercise to help you see that we always have something for which to be thankful. It's not always easy to remember that. But we can look at small inconveniences and find things for which to be thankful. It will only become easier to find things to be thankful for, and to thank God for, when times are hard. SR

## Devotional

Connection Rejection

The Coroner had listed the deceased's cause of death as "Connection Rejection." He wasn't surprised when the D.A.'s office called for a clarification of his findings.

"Can you explain what you mean by 'Connection Rejection'?" the Deputy District Attorney asked. "My boss is going to need something more than this for her report."

"Connection Rejection," said the Coroner into the telephone, "happens when a person's attempts to connect with other people are not reciprocated. The person's foundational need for relationship is not met, which sometimes leads him to view himself as unworthy of relationship. This negative assessment of himself can lead the person to start making decisions that reflect this perspective. He starts to isolate himself from others, giving up on trying to connect with them. This isolation often leads people to diminish their own worth, and to continue this line of thought by engaging in behavior that is harmful to themselves."

"That's what happened with the deceased," the Coroner continued. "He started viewing himself as a lost cause, so he saw no point in taking care of his physical health, not to mention his psychological, emotional, or spiritual health. He thus entered a downward spiral that ultimately ended his life at a premature age."

"That sounds so sad," the Deputy D.A. commented.
"Could anything have been done to change the course of this person's life?"

"Intervention could have occurred at a number of points in the deceased's life," suggested the Coroner. "Children naturally seek their first connections with their parents,

so a child's early experience with his mother and father is crucial. If his parents are not able or willing to connect with the child, or are not present, then other family members, or members of the child's immediate community, can step in and invite him into healthy relationship opportunities. If a child continues to grow up without healthy connection, he will tend to begin the process of self-isolation, as a perceived means of self-preservation. It's therefore vitally important for us to begin connecting with children who have been rejected by their family or community. It is true, however, that even adults who have lived for many years without connection are able to form relationships, if they can find a supportive environment in which to begin reaching beyond their fears and insecurities. Even though it's more difficult for an older person to learn these connection skills, no one is beyond hope. Since we were created for connection, each of us possesses the capacity to connect, even if this capacity appears handicapped by years of connection rejection."

The Deputy District Attorney wrapped up his phone call by asking the Coroner some final questions regarding the deceased's family history. Then he hung up the phone and lost himself in what seemed like hours of deep reflection.

Coming back down to earth, he gradually noticed the presence of the office mail carrier, Richie, who had just now quietly added a large stack of manila envelopes to his inbox. Richie was always like that, he thought, quietly delivering the mail without saying anything to anyone.

"Hey, Richie," he called the young man back into his office. "I'm headed downstairs for some fresh air. Come on, I'll buy you a Coke." SR

## Family Matters

Because of the way the police, the justice system and society as a whole treats African-Americans, some feel that they must think that black lives don't matter. They are rebelling against that notion with the chant "Black Lives Matter." To be honest, I can't really speak to that issue, because I haven't walked in their shoes. But I tend to believe that what God's Word teaches is that all lives matter. Ken Chroniger has asked me to speak next year at conference on the subject of the "Family." In this context, it has occurred to me that more than ever before, the family is under attack in America — almost to the point where it seems that the preponderance of Americans today no longer think the FAMILY MATTERS.

The attack against the God-instituted family unit has come from many arenas: from government-funded child abortion clinics; the easy access of divorce; the increasing number of absentee fathers; mothers and fathers both working and allowing daycare centers to raise their children: more and more couples living together out of wedlock. The list goes on and on, to the point where today the Supreme Court of our land has passed a law demanding that every state recognize and perform same sex marriages. Couples can't even perform the basic functions of the marriage that God

instituted and called good. Such a union may fulfill the requirements of our fallen society, but it is not and can never be the FAMILY that God intended.

Our nation was founded on the Godly principals of the Christian Family. From Genesis to Revelation, marriage and the family is emphasized and encouraged. #### Life and Death at Green End

The congregation asked for help on a regular basis, and rather than provide it, the SDBs of that era elected to withhold their support.

In between the lines of our history as Seventh Day Baptists, many stories are hidden. One such hidden story emerged several months ago when we received two requests in quick succession about our churches in Rhode Island. The first request was for a listing of all of our Rhode Island churches for a religious history of Rhode Island being written by an *emeritus* history professor from Rhode Island College, Dr. J. Stanley Lemons. After surveying our resources, our list was comprised and sent. Soon after, we received a request from a woman asking about the history of an SDB church located at Green End, RI, which was not on the list we had just sent. A church, which was not part of any of our church lists, emerged from the research which followed — and a once hidden story is hidden no longer.

Green End was apparently located on the sea coast near South Kingston, Rhode Island. Geographically speaking, it is not far from our other historic Rhode Island congregations, and had a postal address in Perryville, RI. Perryville is located just north of US Highway 1, between Charlestown and Matunuck.

The first references to SDB work in South Kingston are from 1825, when Elder Matthew Stillman stopped and preached there as part of a trip through the area. There is no reference of a church beginning at that time. In 1843, the SDB Register (our publication directly before the Sabbath Recorder) records the organization of the church with 13 members on April 9th. The first clerk of the church was William C. Lanphear.

The new little congregation struggled from the outside with two crucial things: pastoral leadership and associational support. Throughout the remainder of the 1840s, the church seems to ebb and flow with the involvement of leaders — doing well when there was leadership help from other congregations, and foundering when it was not supplied with leaders. By the early 1850s, the little group had grown to about 25. In 1853, the Green End congregation reported to the Eastern Association that they were endeavoring to build a meeting house. In response, the association took up a collection and sent money to help with the building project. <sup>3</sup>

The building project seems to have been completed shortly thereafter, early in 1854,<sup>4</sup> though apparently the members of the church required loans to get the project completed. Once again after the completion of the meeting house, the little congregation begged for support in the form of pastoral leadership. The Eastern Association had been supporting the work of Henry Clarke to aid the little church. This aid continued until

1856, when enthusiasm for supporting the little church ran out and the work ceased to be supported. In 1857, the Association allocated \$100 to aid in the hiring of a minister, but there is no record of any pastor or leader ever being hired. The reports continue in a negative vein from there, as the church failed to find a leader. With the addition of the debt from the construction of the meeting house, the church was even more burdened. In 1865, the Missionary Society sent a missionary to inquire after the health of the group, but the town was quarantined for small pox, and the missionary was advised to stay away. By 1876, a missionary reported that the church had been "undermined by Seventh Day Adventists," and was no longer in fellowship with Seventh Day Baptists.<sup>5</sup>

Putting the remaining pieces of the puzzle together, it seems that when SDBs failed to support the congregation, and deep in debt, they reached an agreement with the Adventists to make use of the building, providing they could pay the mortgage. In time, as the Adventists grew and cared for the meeting house, they seem also to have gained the trust of the members of the Green End church. They ultimately sold the building to the Adventists and became members of the church. In short, the little church ceased to be an SDB church because it was neglected by Seventh Day Baptists. The congregation asked for help on a regular basis, and rather than provide it, the SDBs of that era elected to withhold their support. That withholding came despite the affirmation of the work at Association meetings. There was much talk about supporting the congregation at Green End, but too little action.

The lesson for us in this is clear as we once again focus on church planting: talk is cheap, and planting is hard work for all of us. If our efforts to cooperatively plant new SDB churches is to be successful, we must move past affirming the work of spreading the Gospel in committee meetings and into doing the work of supporting with our prayers, our dollars, our time, and our hands — the work of advancing the Kingdom of God in Jesus Christ. We must do the hard work of training leaders whom we can commission to go elsewhere and lead well. Local churches will have to focus their attention to this in order to be successful. If we fail in this, many more of our churches will become "hidden" stories in the pages of SDB history.

#### What Should Your Church Be Aware Of? The U.S. Supreme Court Decision Regarding Same-Sex Marriage

The U.S. Supreme Court issued a ruling on June 26, 2015, holding that the Fourteenth Amendment requires a state to license a marriage between two people of the same sex. This decision also requires states to recognize a marriage between two people of the same sex when their marriage was lawfully licensed and performed in another state.

Although this seems to be a landmark decision, this ruling does not appear to take away any of the rights that religious organizations currently have under the law. The First Amendment ensures us that religious organizations and persons are given proper protection as they seek to teach the principles that are so vital to their lives and faith, and to their own deep objectives to continue the family structure they have long valued. Still, this ruling leaves unanswered questions, and those questions could lead to confusion and concerns for our churches and their ministries.

With this in mind, what should our SDB Churches do? What should our SDB Pastors do?

#### So What Does This Mean for Churches?

This ruling does not appear to take away any of the rights that religious organizations currently have under the law. Still, the ruling leaves concerns for ministries. Common concerns include whether a pastor must perform a samesex wedding ceremony or whether a church must make its facilities available for same-sex wedding events. We do have some things we should do in our churches to ensure we are being compliant with the law of the land.

#### **Communicate Expectations**

Your church should have Biblically-based beliefs and policies documented in the bylaws, articles, and other foundational documents. Stating the church's belief, along with applicable reference to scripture in your governing documents, can help avoid claims of improper discrimination. Churches and ministries will do well to clearly communicate what the church's positions and policies are based on sincerely held religious belief. This lays the foundation for the ministry to operate in accordance with its stated belief, found in the bylaws.

Your church must be consistent in its response to questions. The church or ministry cannot treat an individual or a group of people differently than it does another person or group. For example, if the church offers the sanctuary or event center for rent to the general public, yet declines to allow a same-sex couple to rent the facility, the individual whom the church declined may have a valid claim of discrimination. The odds of the church losing a lawsuit increase significantly. Your church would be better served only renting to members of the church.

#### Take Steps to Avoid a Lawsuit

To reduce the likelihood of an individual bringing a successful same-sex-related lawsuit against your church, your church might want to consider the following steps:

- 1) Include a spiritual purpose provision in the governing documents/bylaws. Be sure the organizational governing documents clearly state the ministry's spiritual purpose, reliance on scripture, and the intent to advance the ministry in accordance with scripture. Where appropriate, quote scripture within the purpose statement.
- 2) Respond with sensitivity. Train the clergy, staff, and volunteers to approach individual needs and requests with empathy. Although the church cannot meet every request or demand, the manner in which it conveys its response is sometimes as important as what is decided.
- 3) Consult with local counsel. If your church is revising its organizational documents, ministry policies, and procedures, it should involve a local attorney. A wide variety of federal, state, and local laws apply to employment and facilities use. Consulting with a local attorney can provide guidance on any state-specific and local legal issues that the church may encounter.

I hope that this has been helpful. Following the steps listed above can help our churches continue to operate in accordance with their sincerely held religious belief. [SR]

### **Body Fat**

Fat is an organ that can help or harm your health. Everyone has fat; we need it to survive. The trick is understanding the difference between the kinds of fat and keeping them in balance with diet, exercise and common sense.

Subcutaneous fat lies directly underneath the skin. It stores energy and provides essential padding. It also generates adiponectin, a hormone that helps regulate insulin production. The more fat, the less adiponectin produced, which causes the body to have trouble regulating insulin, increasing the risk of heart disease and diabetes. Blast it off by cutting calories and exercising. Even little bursts of energy help. If you already exercise step it up, as a higher exertion level helps the body to keep burning fat even after the activity ceases.

Visceral fat is nestled deep within the belly, padding the spaces around the abdominal organs. You can't feel or grab it. It secretes inflammatory proteins called cytokines that affect insulin production and increase inflammation throughout the body raising the risk of developing type 2 diabetes and heart disease and earning the name "toxic fat." It is usually visceral fat that we add as we age. To reduce this type of fat, eat a balanced diet with lean protein while controlling your carb and fat intake. Aerobic exercise is the best workout.

Ectopic fat has the same metabolic properties as visceral fat, but settles in the heart, liver, pancreas and muscles. Most have only a few pounds but it is dangerous because it's inside vital organs increasing the risk of heart disease, liver damage, and type 2 diabetes. The more you sit the more likely you are to have this type of fat around your heart. Stay active.

Brown fat is mainly around the neck, collarbone and chest. Although it has been assumed that it is present only in infants, helping to keep them warm, recent studies reveal that some adults still have brown cells. It becomes

metabolically active when we're exposed to cold temperatures, burning up energy. Because it generates heat, it burns more calories at rest. To activate this fat, prepare to shiver. Spending 10-15 minutes in temperatures below 60 degrees produces a hormone called irisin, which appears to make white fat cells act like brown fat — so keep the thermostat low. Brown fat may reduce the risk of diabetes because it vacuums up excess glucose from the blood.

The number of fat cells you have is set early. You don't get more of them when you gain weight. Instead, the fat cells swell as triglycerides are stored in them and as the fat cells swell so does the body. Boys tend to be born with more fat cells in their belly, while girls are born with more in their hips, thighs, and butt. Between the ages of 9 and 19 the volume of fat in girls more than doubles due to a surge of estrogen. Post-pregnancy fat is hard to get rid of because it's reserve storage for the demands of breast feeding. The body is hardwired to hold onto some of these reserves until after you wean the baby. Once women go through menopause, their fat storage tends to mimic that of men's. You may start sporting what looks like a beer belly instead of storing fat around the hips and thighs.

Three ways to burn flab faster include resistance training, rest, and relaxation. A strength workout that incorporates high intensity interval training will help burn calories and fat stores at a higher rate than straight sets. Lack of sleep can wreak havoc on hormones that control fat metabolism. Finding ways to relax may reduce cortisol levels (high levels of the stress hormone are linked to belly fat). Some examples are yoga, prayer, meditating on God's word, or listening to hymns or praise songs. Fat, essential to our health, may also cause us to be unhealthy. Once again proper diet, exercise, rest and relaxation will keep us whole.

When her mother became pregnant with her, they went back to Jamaica for her birth, and returned to Cuba when Gladys was 10 months old. Unfortunately, her mother died when she was 5 years old and she was raised by two female guardians. In her formative years, she attended a Baptist Union Church regularly, while learning both English and Spanish, so she was fluently bi-lingual. In her youth, she received Jesus Christ as her Savior, but was never water baptized, nor did she become a member of any church.

In 1954, Gladys married Isaiah Hamilton. Five years later, following the Fidel Castro-led revolution in Cuba, the couple returned to live in Jamaica.
